Introduction

Thank you for taking the time to read 350 Global's Policy Plan for 2024 / 25. We are delighted to have launched 350 Global this year to join the wider 350 global community seeking to protect our society and future generations from the impacts of climate change.

350.org is an international movement of ordinary people working to end the age of fossil fuels that was founded in the US in 2008, on the conviction that people are the most powerful agents of change. 350 Global has been established and incorporated in the Netherlands as a sister organisation to 350.org Global. We will work directly with partners and our grassroot network to strengthen, empower and grow the climate movement and educate the public on climate justice issues and sustainability. We work with people across the world to oppose those wrecking our climate and to fight for a sustainable future.

We put particular emphasis on efforts to challenge the unequal systems and power relations that have led the world to the climate disaster we face today. We take an intersectional lens to our work and strive to bring leadership from the global majority world: working with marginalised and frontline communities, most heavily impacted by the climate crisis, despite having contributed the least to it.

We hope that you will be encouraged by the work of 350 and feel a sense of hope in the future we are seeking to create.

Public benefit aims and activities

350 Global has been set up to protect our society and future generations from the impacts of climate change through campaigning, organising, research and public education.

We currently seek to do this through four key pillars of work:

1. Building the movement of the future

This category encompasses our work to build and connect a strong climate movement, empowering activists and new climate leadership. It includes projects with a particular focus on mentoring, coaching and training, as well as those dedicated to developing and nurturing coalitions and networks.

2. Stopping fossil fuel finance

This category encompasses our work to stop the financing of climate disaster, by targeting the institutions bankrolling new fossil fuel developments. It includes calling on public and private banks, insurers, pension funds, shareholders and governments to end all investment in coal, oil and fossil gas.

3. Keeping fossil fuels in the ground

This category encompasses our campaign work to keep fossil fuels in the ground, an essential component of the fight for a safer climate. It includes highlights of our efforts which delayed, blocked or stopped the extraction (digging, drilling, fracking and more) and burning of coal, oil and fossil gas.

4. Powering up equitable and just transitions

This category encompasses our work to ensure a just transition. This means a fight for clean and renewable energy systems rooted in principles of justice, ensuring that people, not profit, are at the centre of decision-making. It includes advocating to remove barriers to renewable energy solutions, alongside calling for fair financing, and strong and transparent legislation.

350 Global works on grassroots campaigns across the globe, leveraging people power — individuals working together in pursuit of a common goal — to dismantle the influence and infrastructure of the fossil fuel industry and to power up clean systems rooted in justice.

To build a more sustainable and just future, we collaborate with communities at the frontline of the climate crisis, those who have historically contributed the least emissions but are feeling the worst effects. We campaign and organise to show the world we really want, in pursuit of energy justice and distributed renewable energy solutions that will move us away from fossil fuels, for good.

In this, our first year as a registered organisation in the Netherlands, we will be seeking to raise funds in Europe through digital campaigns direct towards the public, communications with our supports and, networking and outreach to funders who are active in the climate campaigning sphere. We will also continue to engage with our supporter base in the Netherlands and contribute to the activities of the global 350 network. 350 Global has no intention of raising funds for commercial activities and will ensure all of its expenditure is on charitable activities.
